FEBRUARY MEETING MINUTES

MINUTES OF THE FEBRUARY 18, 2024 MEETING OF THE INDIAN HAMMOCK HUNT AND RIDING CLUB, INC. BOARD OF DIRECTORS

CALL TO ORDER

David Bass called the meeting to order at 8:02 AM. The BOD members in attendance were David Bass, Joe Coyle, Corey Miller, Matt Rector, Tim Ward, Barbara Roberts, and Carla Sapp.

PLEDGE OF ALLEGIANCE

The pledge of allegiance was recited.

APPROVE JANUARY 21, MEETING MINUTES

After the reading of the minutes, Corey Miller moved and Tim Ward seconded to approve the January 21 meeting minutes with amendments. The motion passed unanimously.

TREASURER'S REPORT Corey Miller Chair

Corey Miller reported that Indian Hammock was approximately \$13,000 over budget due to five working weeks in January.

Corey Miller moved and Barbara Roberts seconded to add Laverne Klein to the Finance Committee. The motion passed unanimously.

Corey Miller moved and Matt Rector seconded to approve the purchase of a 2016 RAM 2500 truck for the manager for \$40,000. The motion passed unanimously.

Corey Miller moved and Barbara Roberts seconded to move the money from the MidFlorida Credit Union account to the South State bank Account 4352. The motion passed unanimously.

Corey Miller moved and Barbara Roberts seconded to move the operating account from the Seacoast Bank to the South State Bank. The motion passed unanimously.

Corey Miller moved to purchase a chopper for \$4000. There was no second, so the motion died.

MANAGER'S REPORT: Matt Dorriety, Manager

Matt read his manager's report and the Accounts Receivable report to the assembly. The manager's report will be in the Hammock Herald.

Matt Rector and Matt Dorriety agreed to present the cost to add cameras at the Mall to the Finance Committee.

COMMITTEE REPORTS:

Architectural Review Committee: Michael Gildemeyer, Chair

George and Jason Stark, Lot 130. Clear north area of lot up to 25" buffer line. Corey Miller moved and Barbara Roberts seconded to approve this request per the Architectural committee recommendation. The motion passed unanimously.

Bob Baum, Lot 185. Install archery target structure. Clear and rock an area for trailer parking. Matt Rector moved and Barbara Roberts seconded to approve this request per the Architectural committee recommendation, providing the following conditions are met:

- Member acquires any necessary county permits.

- Archery target is a minimum of 120' inside the property line.
- Member assumes any and/or all liability.
- Member is aware this is his third structure on the property.

The motion passed unanimously.

Newman, Lot #83: Repair observation deck, replace the existing fire pit and place 2' of select rock around the pond. Barbara Roberts moved and Carla Sapp seconded to approve this request per the Architectural Committee recommendation. The motion passed unanimously.

Breza, Lot #158/159: Install a house sub-grade pad and fence. Barbara Roberts moved and Corey Miller seconded to approve this request, providing all Okeechobee permits are pulled. The motion passed unanimously.

Matt Rector moved and Carla Sapp seconded to approve the Project Completion Affidavit and send it to the lawyer for his review. Members will be required to complete this affidavit before their deposit will be returned.

Membership Committee: Tom Brooks Chair

Mark and Joan Terwilliger are purchasing Lot 60. Matt Rector moved and Tim Ward seconded to waive the right of first refusal and approve these new members. The motion passed unanimously.

John and Laura Kolshak are purchasing Lot 8. Corey Miller moved and Carla Sapp seconded to waive the right of first refusal and approve these new members. The motion passed unanimously.

Pat and Melissa Presutti are purchasing Lots 240 and 241. Matt Rector moved and Corey Miller seconded to waive the right of first refusal and approve these new members. The motion passed unanimously.

Shanna Bernkrant is purchasing Lot 131. Matt Rector moved and Tim Ward seconded to waive the right of first refusal and approve this new member. The motion passed unanimously.

Christopher and Susan Zayac are purchasing Lot 177. Corey Miller moved and Carla Sapp seconded to waive the right of first refusal and approve these new members. The motion passed unanimously.

Shotgun Sports Committee: Report by Corey Miller for Lauren Miller Chair

Matt Rector moved and Tim Ward seconded to allow the committee to spend up to \$5000 for two new machines. The motion passed unanimously.

Firewise Committee: Sandy Steinruck chair

Matt Rector moved and Corey Miller seconded to allow the committee to host a fire training session on Saturday, March 9, at 10:00 at the Bird's Nest. The motion passed unanimously.

OLD BUSINESS:

Fitness Committee approval

Barbara Roberts moved and Corey Miller seconded to approve the Fitness Committee. (It was mistakenly left off the list last month.) The motion passed unanimously.

Notice of Proposed Fine for Lot 207

Joe Coyle moved and Tim Ward seconded to not fine Lot 207 based upon the Notice of Cancellation he received from Citizen's Insurance on December 12. The motion passed unanimously.

Matt Rector moved and Tim Ward seconded to ask the ARC to confirm the location of the new fence on Lot

207. The motion passed unanimously.

Resolution of Minor Common Area Encroachments

Barbara Roberts moved and Tim Ward seconded to approve the affidavit license agreement with the following amendments and conditions for any member who unbeknownst to them has a fence on common property.

Conditions for the Club/Board to consider when attempting to grant a license agreement for minor/de-minimis fence/structure encroachments:

When determining whether to grant a member a license to maintain a fence or other structure on the Club's common area property, the Club should consider the following:

The structure/fence must have been constructed/built on or before the effective date of this policy which is February 18, 2024, and all the below conditions must be applicable:

- 1. Whether the encroachment by the member was willful and/or intentional (in which case a licensing agreement generally will not be appropriate) or whether the encroachment was accidental and unintentional (in which case a licensing agreement may be appropriate);**
- 2. The scope of the encroachment and whether the encroachment can be considered minor or de minimis;**
- 3. Whether the encroachment is imposing any type of significant detriment to the Club;**
- 4. Whether the cost for the removal of the encroachment by the member will be a substantial cost and/or detriment to the member; and**
- 5. The benefit that the Club will receive upon the removal of the encroachment.**

If the Board determines that the use of a licensing agreement for a minor encroachment onto common area land would be appropriate, the Board may agree to allow the member to maintain the structure on common area land in exchange for nominal consideration. As part of the licensing agreement, the member would agree that he or she is not claiming any type of ownership of the encroached property by adverse possession or otherwise. Any licensing agreement would also generally require that the member maintain the structure in good condition, and that the license will expire upon the removal of the structure by the member. The Board should also consider **termination of the agreement and a requirement that the structure be removed by the member if it is more than 50% damaged or destroyed. The Board should further consider whether the license should be personal to the member and not be transferable to any new owner of the Residential Lot, so that the encroaching structure must be removed upon the transfer of the lot.**

The motion passed, with Corey Miller and Carla Sapp voting against it.

Book of Rules Revisions

Matt Rector moved, and Carla Sapp seconded to approve the following two revision to the Book of Rules. The motion passed unanimously.

Section 2.3

All other committee Chairs not referenced in Rule 2.2 ~~are encouraged~~ **must post their committee meeting at the community bulletin board at the gate., ~~on the IH website, or both.~~ Any other methods of communication to membership are also encouraged.**

Matt Rector moved and Carla Sapp seconded to approve the following revision to the Book of Rules. The motion passed unanimously.

Section 2.3

Committee meetings shall be open to all Owner/Members and/or permitted Family, unless the ~~Committee Chair~~ Board of Directors determines that the meeting is specifically around IH personnel or a matter pertaining to litigation, at which time the meeting is deemed closed.

Corey Miller moved and Barbara Roberts seconded to approve the following revision to the Book of Rules. The motion passed, with Matt Rector voting against it.

2.5.6. Committees cannot spend money or add assets without the Board of Directors' approval. Prior to any approval, committees must present any spending plan to the Finance Committee for review.

Matt Rector moved and Carla Sapp seconded to approve the following revision to the Book of Rules. The motion passed unanimously.

5.3.1.7 The owner must present to the manager in writing or by email the name of the person and date(s) the gate card is intended to be used. If the temporary gate card request is for fifteen (15) days or less, the manager may issue the gate card upon receipt of the written request. The manager may extend the temporary gate card access for one additional fifteen (15) day period if necessary while requesting additional access time from the Board as stated in 5.3.1.8.

Matt Rector moved and Tim Ward seconded to approve the following revision to the Book of Rules. The motion passed unanimously.

15.6.2.3. Outdoor campfires are prohibited during periods of high fire risks as determined from time to time by the Manager. Times of prohibited fires will be posted at the entrance gate. When permitted, outdoor campfires must comply with the following requirements:

Matt Rector moved and Carla Sapp seconded to approve the following revision to the Book of Rules. The motion passed unanimously.

Appendix A/ Legal Actions

Fines shall be paid within ~~ten (10)~~ five (5) days following the date the notice of hearing result is to the Member. Failure to pay confirmed fines will result in delinquency and collection procedures.

Matt Rector moved and Carla Sapp seconded to approve the following revision to the Book of Rules. The motion passed unanimously.

Appendix A/ SUSPENSIONS (FOR NON-PAYMENT OF FINES).

b. The Club ~~will~~may suspend the voting privileges of a parcel or member for the non-payment of any monetary obligation due to the Club, including a fine that is more than 90 days delinquent.

MANAGER'S REPORT FEBRUARY 2024

Manager's Report February 2024

To the Board of Directors:

Gate: One member of our Gate staff will be leaving regular employment at Indian Hammock to join the Florida Highway Patrol. Mark Green has begun training his replacement, and his final day of regular gate duty will be February 24. He will still reside in the Hammock and will be available to fill in on occasion at the gate. The new member of our gate staff is Susan Furiato. Please make her welcome, and be patient with her as she learns the gate duties and the members of Indian Hammock.

A temporary 15-day gate access pass was issued for Lot 268, per Rule 5.3.1.7.

Committees: The roller chopping of the Quail Field and Hunt Area 1-B started on Jan 22 and finished on Feb 6. We've had several equipment breakdowns that resulted in a total of about 4 days of downtime, but were able to get it back up and running to finish the immediate project.

I have been working on several requests from the Finance Committee, including a plan for additional fire and wind protection of Hammock buildings and the related costs.

At the request of the Preservation and Hunt Committees, I have spoken with a certified burner and will be bringing him out to the Hammock to look over some areas that need to be burned. The meeting is tentatively set for Tuesday, February 20. John Kassing from Hunt, Mary Jo Barkaszi from Preservation, and Sandy Steinruck from Firewise have requested to be present at the meeting.

Appeals Committee: Nothing to report.

Trap and Skeet/Bird's Nest: The staff has started on the upgrades and repairs to the kitchen at the Bird's Nest, so it is unavailable for rental at the present time. They have also built new stairs to replace the rotten stringers at the high houses, as well as repairing and replacing a few more areas of rotten wood. These areas will be painted as soon as possible to preserve the wood.

Sunshine Roofing has finished re-roofing the Bird's Nest and Bar-B-Que Pavilion with metal roofing, and our staff has re-painted the new fascia boards.

Rifle/Pistol Range: We have started pressure washing, painting, and replacing rotten wood on the shelters at the range.

Lodge: Our staff has completed work on the Lodge road, laying down new shell and 89 stone for better durability during the rainy season. Our next project at the Lodge will be the replacement of the front decking, ramp, and railing. Hardi-board will also be added around the entrance to replace the wood siding and all new wood will be painted.

Complete Electrical has repaired the generator at the Lodge, and we now have it under a service agreement so it will be checked semi-annually by a service technician. I have also met with the service technician, so I now have a better understanding of how it works and what to check on.

Fitness Center: New impact resistant doors are on order for the Fitness Center. We will install and paint them as soon as possible after they arrive.

Roads, Land and Drainage: The track hoe rented from Ring Power was picked up on Jan 31. We now have #1 and #2 fill dirt available. The staff has filled in holes in the Low Road and has been working on fulfilling member services requests for fill dirt, which will continue as time permits.

A semi attempting to make a hay delivery to an incorrect address couldn't make the turn at Gator Cave Road and Pine Hill Drive. The driver jack knifed the truck, and the landing gear ripped up the chip seal road. The trucking company called Fleet Masters Towing & Recovery, and after several hours of work they removed the semi, re-set our road sign, and patched the chip seal road. The trucking company was provided with the correct address for future deliveries.

Mowing is finished in the Outback area, so more time will be available for the staff to work on other scheduled work.

At the 2024 Shot Show, the National Shooting Sports Foundation (NSSF), the Firearm Industry Trade Association, honored three new inductees into their Hall of Fame. One of those individuals was a long-time Indian Hammock Member and Shooting Sports Chair, Bob Morrison. As you will note from the article below, Bob is also a recipient of NSSF's highest honor, the "Ken Sedleky Lifetime Achievement Award". The NSSF Ken Sedleky Lifetime Achievement Award recognizes individuals who have distinguished themselves by their long-term commitment to the success of the industry and by their support of NSSF's mission to promote, protect and preserve hunting and the shooting sports. Another recipient of that award was Steve Hornady, President of Hornady Manufacturing Company, a name any avid gunner will recognize. To be awarded the NSSF's Lifetime Achievement award and be inducted into their Hall of Fame is a lofty achievement indeed.

Bob Morrison was my Co-Chair at Trap & Skeet for almost a decade. It was my pleasure to serve with Bob in that capacity, and although he always insisted that I was the greatest Co-Chair ever, I always believed the opposite was more likely the case. Bob was also the Chairman of the Rifle & Pistol Committee for many years, and worked tirelessly to increase safety procedures and awareness for our ranges. In fact, Bob was the driving force behind the development of the RSO program at Indian Hammock. Many members received their RSO certification at classes that Bob held in the Lodge, and the quantity of RSO's in the Hammock is a testimony to his dedication and success. We have more RSO's per square mile than any other Community in the country, and likely enough to make even the Chairman at the NRA's annual convention blush.

It has been my pleasure to be friends with Bob, and I personally honor him for the contributions he has made to our community and our range safety programs. Judging from the accolades he has received in the article below, he has also made a significant difference in popularizing shooting sports and hunting participation nationwide. These three leaders were recognized for accomplishments that significantly strengthened industry and expanded the shooting sports.

Joe Bartozzi, NSSF President and CEO, praised the contributions of the three individuals in remarks made at the NSSF Members Meeting at the SHOT Show. SHOT Show is the largest trade show of hunting, shooting, law enforcement and outdoor-related products in the world. More than 2,500 exhibitors are displaying their products and services at the 2024 show.

“On behalf of a grateful industry, I take great pride in recognizing trailblazers like Don Gobel, Grits Gresham and Bob Morrison and their many professional accomplishments. They have played important roles in America’s story and heritage of firearm manufacturing and popularizing the shooting sports and hunting. They deserve our respect and praise,” said Bartozzi.

Large panels displaying photos and achievements of the inductees stand in one of the most heavily trafficked sections of the SHOT Show. “The contributions of these three inductees are directly linked to the success of this great trade show, the embracing of firearm ownership in America and the enjoyment of the shooting sports,” said Bartozzi.

The 2024 inductees to the NSSF Hall of Fame are:

Don W. Gobel

Don Gobel was a former President and CEO of Browning Arms Company and Winchester Repeating Arms as well as a past chairman of NSSF's Board of Governors. Gobel led NSSF's board during some of the firearm industry's most contentious legislative fights in the final years of Bill Clinton's two-term presidency. A passionate hunter, he retired from his CEO positions at both Browning and Winchester Repeating Arms in 2001. Don passed away in 2023.

Claude Hamilton "Grits" Gresham

Grits Gresham was one of the industry's most recognizable writers, photographers and entertainment personalities. For many years, he was the face, spokesman and most visible champion of hunting and the shooting sports on national television. Working alongside NSSF through the 1980s and '90s, he hosted the Where to Hunt and Where to Shoot specials on ESPN, broadcasts of the first made-for-TV shooting event, the Sportsman's Team Challenge, and the Shooting Sports America series on primetime ESPN. A legendary ambassador of the shooting sports, Gresham is a recipient of NSSF's Ken Sedleky Lifetime Achievement Award. Grits passed away in 2008.

Robert Morrison

Bob Morrison's career in the firearm industry was marked by longevity and his tenure as CEO/President of Taurus International Manufacturing. At Taurus, he energized the company through a series of innovative product introductions. Morrison spearheaded a strategic partnership with the National Rifle Association that boosted participation in the shooting sports, while also working directly with industry leaders as an NSSF board member. Morrison is a recipient of NSSF's Ken Sedleky Lifetime Achievement Award.

"The NSSF Hall of Fame reminds all Americans of the pride we take in our industry and the firearm-owning community and what our leaders then and now stand for—the freedom to make, own and use firearms responsibly in America," said Bartozzi.

n Target

THE BASICS: SKEET SHOOTING

Skeet Shooting is the sporting competition for those who want to strategically move around a field that is set up in standardized distances. Shooters are grouped into “squads” with each squad made up of five shooters. Skills are sharpened in agility as shooters move around the course. Left-handed shooters normally do well in this sport. It’s a great game for men and women to compete together because of the uniform series of shots that keep the competition even.

THE SKEET FIELD

The skeet fields are arranged in a half-moon with 8 shooting stations and 2 trap houses. Shooters move from station to station, ending up in the center at the end of the round. There is a high house on the left side of the field, which throws its clay targets from a trap 10 feet above the ground. The target rises to a height of 15 feet by the time it travels to the center of the field. The low house target is on the right side and leaves the trap house just 3.5 feet from the ground. It rises to a height of 15 feet by the time it reaches the center of the field.

A ROUND OF SKEET

A round of skeet consists of 25 targets, of which 17 targets are shot as singles and 8 as doubles. The first miss is repeated immediately and is called an “option”. If no targets are missed during the round, the last is shot at the last station, low house 8.

The shooting sequence is as follows:

- Stations 1 & 2: High house single, low house single, high house/low house pair
- Stations 3, 4 & 5: High house single, low house single
- Stations 6 and 7: High house single, low house single, low house/high house pair
- Station 8: High house single, low house single

RULES: TRAP & SKEET FIELDS

- A maximum of two shells can be loaded at any one time.
- No moving from one shooting position to another with a loaded firearm.
- Only load at the shooting position, DO NOT load your firearm behind other shooters!
- Shot sizes only between 7.5 and 9 are permitted with load size no greater than 1-1/8 oz. and 3 drams of powder. This means, slugs and shot shells between 00-7 are NOT permitted on the clay shooting fields. If you do not know what load your shells are or are not familiar with shot shell load information do not load your firearm without approval from a Range Safety Officer.
